
"America First"


- The effort to bring manufacturing back to the United States and bring fairness to trade agreements
- However, not many other sectors enjoy a trade surplus like agriculture

Why trade matters: 2017 U.S. export destinations

In 2017, the United States exported nearly 15 percent of domestic milk production

The 2018 industry goal was to increase that to 20 percent

Q1 2018 showed strong progress toward 5 percent goal

Recent tariffs





- Tariffs on cheese were raised to 10-15 percent on June 5, 2018
- Higher tariffs imposed on July 5, 2018
- Will increase cost to export by approximately \$90 million



China

- Additional 25 percent tariffs imposed on July 6
- Wide array of dairy products included
- Will increase cost to export by approximately \$102 million

And then, agriculture gets a \$12 billion relief package

- USDA announced aid to farmers hurt by tariffs on June 24
- Direct payments to producers
 - Soybeans, sorghum, corn, wheat, cotton, dairy and hogs
- Product purchases for food banks and other
 - Fruits, nuts, rice, legumes, beef, pork and fluid milk
- Additional funds for trade promotion
 - Similar to current Market Access Program

How will direct payments work?

- It's unclear the amount available to dairy producers
 - Based on loss of markets from retaliatory tariffs
- Payment limits on amount available to any one farm expected
- Unclear mechanism to make payments
- Payments expected September/October
- Crop payments will come at harvest time

North American Free Trade Agreement

Tale of two different trading relationships

- Mexico strong trading partner
 - No. 1 export market
 - Free and open trade
 - Critical to U.S. dairy industry
- Canada protectionist dairy program
 - Supply management system limits imports
 - Most dairy products face 200–300 percent tariffs
 - New Class 7 program made for NAFTA negotiations

Meanwhile, other countries move forward

Farm Bill 2018

House

- Partisan Farm Bill process
- Failed on May, 213-198 due to process and Freedom Caucus
- Second vote passed narrowly, 213–211

Senate

- Bipartisan effort
- Bill passed out of committee, 20-1
- Very strong vote, 86-11
- Now we move to conference



Dairy provisions similar in House and Senate

- Makes the program more affordable for small farms
- Provides more coverage options for all farms
- Makes the program more accessible to large farms
- Eliminates production history adjustment going forward



Differences — not many

Dairy is not expected to be the hold-up as it has in the past

- Senate provides additional discounts for under 2 million pounds
- House allows participation in both MPP and LGM
- Senate allows sign-up annually, House requires one election
- Senate creates a dairy product donation program
- House creates various feed costs studies


- Name?
 - Dairy Risk Management (House) or Dairy Risk Coverage (Senate)

Challenges to passage

- House bill makes major changes to SNAP
 - Supplemental Nutrition Assistance Program
- Senate bill does not include same changes
 - Nor could such changes pass the Senate
 - Need 60 votes
- Current Farm Bill expires end of September
 - Leaders hope to complete work by then
 - If not, we will have an extension
- Will the president sign a Farm Bill without significant SNAP changes?



Farm labor

- No real legislative action
- Enforcement action has been focus
- Bills have gotten votes but lack enough support to pass
- The dairy industry needs a program
 - Currently no program for dairy!
 - Need something to address the current workforce and provide for a future workflow



Milk labels – "Almonds don't lactate"



- Finally the FDA has acknowledged that they haven't been enforcing current standard of identity for milk
 - Current standard "Milk is the lacteal secretion, practically free from colostrum, obtained by the complete milking of one or more healthy cows." They also allow for goat, buffalo, camel...
- There has been an explosion in the dairy case
